

**Agreement to be Bound by Terms of Operating Agreement  
No Small Potatoes Investment Club, LLC**

The undersigned has reviewed the Operating Agreement for No Small Potatoes Investment Club, LLC which is attached as Annex A to this statement, and hereby confirms his or her understanding of it and agrees to be bound by its terms.

Participation in No Small Potatoes Investment Club, LLC involves significant financial risks and is suitable only for persons of adequate financial means who can bear the economic risk of a complete loss of their membership capital contribution. MEMBERS SHOULD ONLY JOIN THE INVESTMENT CLUB WITH MONEY THEY CAN AFFORD TO LOSE. THERE IS NO GUARANTEE THAT MEMBERS WILL PROFIT FROM MEMBERSHIP IN THIS INVESTMENT CLUB. **IT IS POSSIBLE THAT MEMBERS WILL LOSE ALL OR SOME OF THEIR CAPITAL CONTRIBUTIONS.** PAST PERFORMANCE IS NOT NECESSARILY INDICATIVE OF FUTURE RESULTS.
